Where the matter proceeds remotely, arrangements may be made to allow for attendance of members of the public and the media provided that an **advance notice of 24 hours is given**. Such notice must be given by entering your name and a valid email address.

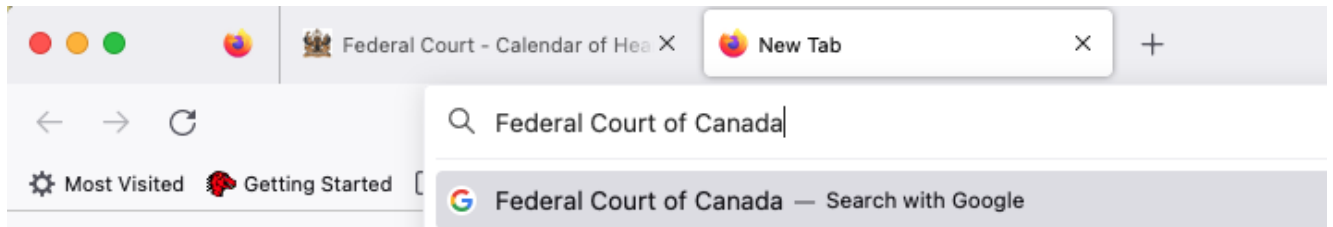
The deadline to register is September 21, 2023 at 10:00 a.m. (Mountain).

STEP ONE

Click on the link to the Federal Court website:

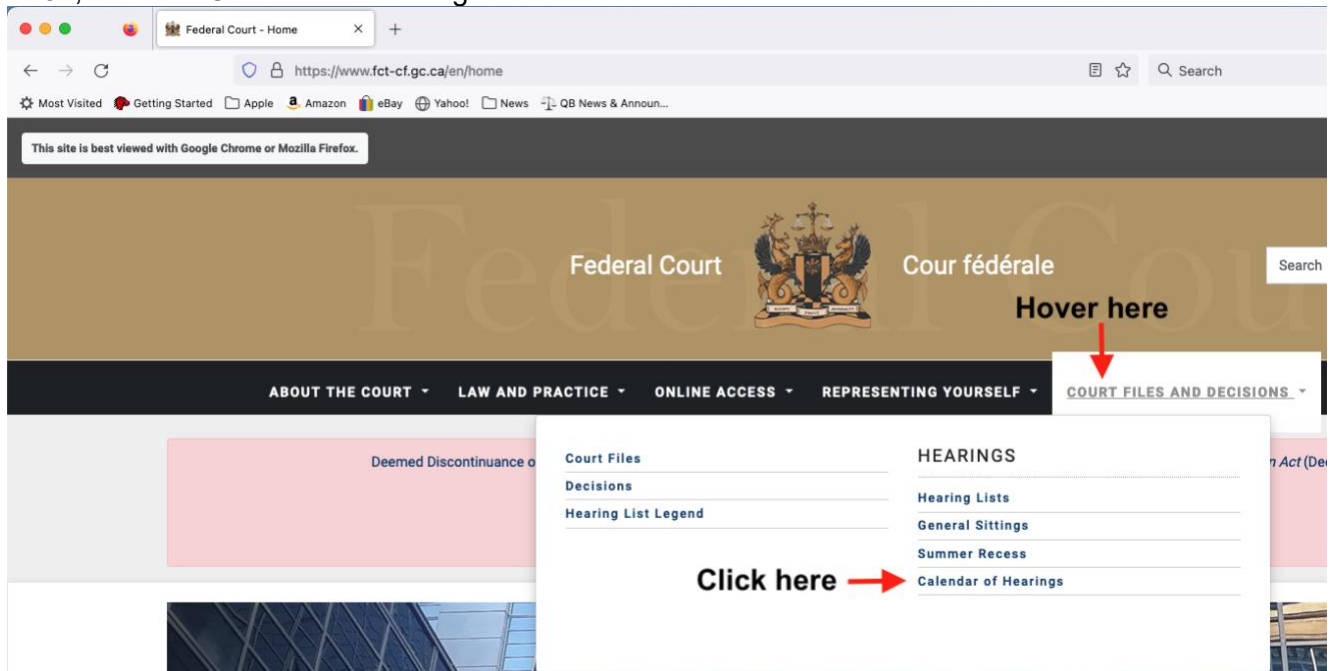


STEP FOUR

ORDER

UPON a case management conference having been held this day with counsel for the parties;

AND UPON hearing the submissions of counsel for the parties;

AND UPON being alerted following the case management conference that when communicating the parties' availabilities to the Court, there was a typo in the Plaintiffs' letter and September 21 is not an available date;

THIS COURT ORDERS that:

1. A special sitting shall be held by way of Zoom videoconference on Friday, September 22, 2023 at 10:00 a.m. (Mountain) to hear the Plaintiffs' motion for conditional approval of the settlement and discontinuance of the action pursuant to Rule 114(4) of the Federal Courts Rules.
2. The Plaintiffs shall serve and file their motion record no later than September 12, 2023.
3. The Plaintiffs shall provide notice of the motion to the affected band members by posting on the band's social media website.
4. On the Court's own motion, the style of cause is amended, with immediate effect, to reflect the Crown as "His Majesty the King in right of Canada".
